### **PHCQA News:**

#### STS Pilot Project

PHCQA has started working on a pilot to become one of the first organizations in the nation to make comparable measures from the Society of Thoracic Surgeons (STS) national database available for free on a public website. The first phase will involve 4 to 6 hospitals voluntarily making some of their cardiac care data publicly available via the PHCQA website. Clinical measures such as the STS Composite Score, CABG operative mortality, deep sternal wound infection rates, stroke complication rate, and other indicators will be made available in a special section on the PHCQA website. Timing for the launch of the pilot is to be confirmed but the effort is scheduled to coincide with the release of the new CMS data in December 2010. PHCQA has also applied for grant funding to study the use of cardiac care data in health care decisionmaking.

#### From The Executive Director:



The Pennsylvania Health Care Quality Alliance continues to make progress in helping to build a consistent, statewide approach to health care quality measurement and reporting in Pennsylvania.

In June, PHCQA entered into a partnership with Aligning Forces for Quality in South Central Pennsylvania (AF4Q SCPA) to allow use of PHCQA's reporting infrastructure to display inpatient hospital data for York and Adams County. Integration of PHCQA's software with the AF4Q SPCA website will allow PHCQA's inpatient quality data to be viewed alongside the comprehensive ambulatory care quality measures already in place on the AF4Q SPCA website.

In July, PHCQA was invited to submit a full grant proposal to the Robert Wood Johnson Foundation following a screening process which selected PHCQA and 40 others out of 277 preliminary applications. The RWJF grant would fund a variety of focus groups and physician / consumer surveys to assess the impact of public reporting on cardiac care decision-making. Final grant decisions are expected in September.

Later this month PHCQA will be releasing a "State of the State" report which summarize some of the impressive results that PA hospitals have been able to achieve over the past three years.
